\*\*\*Safe deposit boxes are available at our Oakton branch for Congressional Federal members who have direct deposit or a balance of \$2,000 or more in any combination of Credit Union accounts. Safe deposit boxes are available in a variety of sizes listed above.

The Credit Union will assess a 2% Foreign Transaction Fee on Visa® Credit and Debit Card Foreign transactions, calculated in U.S. dollars, which will be shown independently on your statement. Foreign transactions made with Visa® Signature Premier Rewards credit card will not be charged a Foreign Transaction Fee.
