Congressional Federal offers scholarships to graduating high school seniors attending an accredited college, university, or technical school. Applicants must be a primary member of Congressional Federal in order to be eligible. If you are not already a member and would like to be considered for a scholarship, you may do so by opening a primary savings account with a minimum deposit of \$5.00.

Three scholarships, each in the amount of \$3,000, will be granted to the winners in their pursuit of a college degree. The winners will be announced June 01, 2023.

ELIGIBILITY REQUIREMENTS

1. Be a primary member of Congressional Federal with a savings account in good standing.
2. Be a graduating high school senior with a grade point average of B or above, based upon a 4.0 scale.
3. Use the funds for the purpose of study at an accredited college, university, or technical school. Award funds will be disbursed directly to winner's intended institution.
4. One entry per applicant.

APPLICATION REQUIREMENTS

1. Submit a completed scholarship application.
2. Submit online or attach a one- to two-page, typed hard-copy of your essay on the selected topic:
What is the hardest lesson about money that you have learned so far, either from your own experience or the experience of someone you know?
3. Submit a copy of an acceptance letter from an accredited college or university if available at time of submission.
4. Submit a copy of your most recent grades/transcript. Winners will be required to follow up with an official sealed copy of their school's transcript.
5. Submit a signed reference letter from a non-family member.
6. Deadline for submission of all materials is **April 16, 2023**. All electronic submissions must be uploaded securely at **www.CongressionalFCU.org/Scholarship** by 11:59 PM on April 16, 2023. Submissions by mail must be postmarked on or before April 16, 2023. Incomplete packages will not be considered. The deadline will not be extended under any circumstances.
7. Employees and volunteers of Congressional Federal and their families are not eligible.

SELECTION PROCESS

1. At least one scholarship is awarded to a District of Columbia resident.
2. The final decision is based upon the applicant's essay, to include content, grammar, writing style, and originality.
3. The Selection Committee will review all applications.
4. Winners will be announced prior to the May annual meeting.
5. Winners must submit a photo for the credit union newsletter and website.
