WHAT DOES CONGRESSIONAL FEDERAL CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?

WHY?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
WHAT?	The types of personal information we collect and share depend on the products or services you have with us. This information can include: <ul style="list-style-type: none"> • Social Security number and account balances • Credit history and payment history • Transaction history and overdraft history
HOW?	All financial companies need to share members' personal information to run their everyday business. In the section below, we will list the reasons financial companies can share their members' personal information, the reasons Congressional Federal chooses to share, and whether you can limit this sharing.

What we do	
How does Congressional Federal protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Congressional Federal collect my personal information?	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> • open an account or deposit money • pay your bills or apply for a loan • use your credit or debit card <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> • sharing for affiliates' everyday business purposes— information about your creditworthiness • affiliates from using your information to market to you • sharing for nonaffiliates to market to you
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.
Definitions	
Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> • <i>Our affiliates include such companies as Congressional Financial Network, PSCUFS and Credit Union Mortgage Association (CUMA).</i>
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> • <i>Nonaffiliates we share with can include insurance companies, financial statement publishers or printers, mail houses, data processors and share draft check printers.</i>
Joint Marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> • <i>These joint marketing agreements can be with financial companies such as those that offer securities (investments), insurance and mortgages. A few examples of companies we share with include Affinion, an insurance company, and Securities America, Inc., an investment company.</i>

<ul style="list-style-type: none"> • No mobile information will be shared with third parties or affiliates for marketing or promotional purposes. • No text messaging opt-in and/or consent information will be shared with third parties or affiliates for any reason. • Information may be shared with subcontractors and service providers solely for the purpose of supporting our services, such as customer service, system operations, or compliance functions. <p>Congressional Federal Credit Union maintains personal information in compliance with time parameters stated in federal laws, regulatory requirements, and internal policies and procedures.</p> <p>Congressional Federal Credit Union is regulated by the National Credit Union Administration (NCUA).</p>
